Child Safeguarding Practice Review Panel	New National Review: 'I wanted them all to notice' The Child Safeguarding Practice Review Panel have published a national review about child sexual abuse within the family environment. The voices and experiences of 193 children sit at the heart of this review, which has found that too often, professionals fail to notice and act to help protect children from child sexual abuse in their families. YOUTH ENDOWMENT FUND	'Who Is Afffected by Violence?' Report 2024 The Youth Endowment Fund (YEF) has published new reports based on it Children, Vio- lence and Vulnerability research. Over 10,000 13-17 year-olds in England and Wales took part. Findings include: 20% of young people were victims of violence in the last 12 months, experiences of violence were concentrated among the most vulnerable, and 5% of 13-17 year old have carried a weapon in the last year. childline	Christmas Campaign for Children Experiencing Domestic Abuse Between April and September 2024, the NSPCC Helpline received almost 4000 contacts about concerns for children experiencing domestic abuse (a 19% increase since last year), with Childline delivering over 500 counselling sessions in 6 months.
